Islamabad, the 15th June, 2020

- **S.R.O. 544(I)/2020.**—In exercise of the powers conferred by Section16 (2)(a) read with Section 56 of Pakistan Nuclear Regulatory Authority Ordinance, 2001, Pakistan Nuclear Regulatory Authority is pleased to revise the "Regulations on Licensing Fee by Pakistan Nuclear Regulatory Authority (PAK/900) (Rev.2)" notified *vide* S.R.O.1223(I)/2017. The revised regulations are being promulgated as follows:
- 1. **Short Title, Extent and Commencement.**—(1) These regulations may be called "Regulations on Licensing Fee by Pakistan Nuclear Regulatory Authority (PAK/900) (Rev.3)".
 - (2) These regulations extend to the whole of Pakistan.
 - (3) These regulations shall come into force with effect from 1st July, 2020.

- 2. **Definitions.**—In these regulations, unless there is anything repugnant in the subject or context,
 - (a) "applicant" means a person as defined in the Ordinance who applies to the Authority for a license or an authorization;
 - (b) "Authority" means the Pakistan Nuclear Regulatory Authority established under Section 3 of the Ordinance;
 - (c) "authorization" means an authorization granted under Section 20 or, as the case may be, Sections 21, 22 or 23 of the Ordinance;
 - (d) "Chairman" means the Chairman of the Authority; and
 - (e) "Ordinance" means Pakistan Nuclear Regulatory Authority Ordinance, 2001 (III of 2001).
- 3. **Interpretation.**—The decision of the Chairman regarding interpretation of any word or phrase of these regulations shall be final and binding.
- 4. **General.**—(1) Under the provisions of Section 56(2) of the Ordinance in connection with licensing and regulatory functions, the fee charged by the Authority is commensurate with the nature of the facility or activity applying graded approach and the regulatory efforts involved. The fee and charges are described below:
 - (a) License and Authorization Fee.—The applicant or licensee requiring license or authorization for a facility or activity shall submit an application as required by relevant PNRA regulations along with fee prescribed in Schedule I and Schedule II of these regulations.
 - (b) **Annual Renewal Fee.**—For each financial year, the licensee shall pay renewal fee as prescribed in Schedule I of these regulations. However, for small radiation facilities e.g. X-ray facility, CT scanner, research and teaching institutes, etc., the licensee may pay renewal fee in lump-sum up to a maximum period of five (05) years.
 - (c) Surcharge on Late Payment of Fee.—Annual renewal fee is due on 1st July of each financial year. The last date for payment of

annual renewal fee shall be 30th September. In case where the licensee fails to pay annual renewal fee within due date, he shall pay fee along with 10% surcharge until the end of applicable financial year. If licensee fails to pay annual renewal fee in applicable financial year, he shall pay this fee along with 50% surcharge in next financial year. Cases of non-payment of license renewal fee may be dealt with as per Section 44 of the Ordinance and PNRA Enforcement Regulations - (PAK/950).

- (d) License or Authorization's Transfer and Amendment Fee.—A licensee requiring transfer, amendment or changes in his license or authorization shall deposit a fee prescribed in Schedule III of these regulations.
- (e) **Service Charges.**—Under the provision of Section 56(2)(b) of the Ordinance, the Authority may provide services if requested by the applicant or licensee. The types of services and their corresponding fee are addressed in Schedule IV of these regulations. In case of any service not enlisted in Schedule IV of these regulations, the applicant or licensee shall pay all cost as mutually agreed by the applicant or licensee with the Authority.
- (f) **Expert Consultation Expenses.**—In performing its licensing and regulatory functions by the Authority where consultation of an external expert is necessary, the applicant or licensee shall pay all cost as mutually agreed by the applicant or licensee with the Authority.
- (2) **Payment of Fee.**—Each application for which fee and charges are prescribed shall be accompanied by a remittance for the full amount of fee or as agreed with the Authority in favor of "Director (Finance), PNRA, Islamabad".
- 5. **Repeal.**—The S.R.O. 1223(I)/2017 dated 30th November, 2017 is hereby repealed.
